

Directions: Driving north or south on Interstate 5 you would take the Hwy 126 exit and go west about one mile to the traffic signal at Cambridge View Drive. Turning **left** on Cambridge View Drive takes you into the RV Park. If you are driving east on Hwy 126 from Ventura, you would turn **right** at the Cambridge View Drive traffic signal (about one mile before reaching Interstate 5).
