Membership Meeting
December 3, 2019
Paso Robles, CA**

The meeting was called to order at 9:30 a.m. A quorum was present. The flag salute was led by R. Rendall.

The secretary's report was published in the newsletter. No corrections noted. The report was approved as posted.

The treasurer reported that the chapter's balance was \$15,717, and that as long as our income is less than \$50,000 not taxes need be paid.

Committee Reports

National Director: Randy Gibbs reported on highlights from the National Convention. At the convention, the FMCA Assist program was discussed at great length. The problem with the program is that the escalating premiums are drawing over \$2 million out of the FMCA reserve funds. The National Executive Board made a motion to cancel the program. The vote did not pass. There was a motion to raise FMCA dues \$25 a year to cover the cost of the program. (Go to FMCA.com to see what the program covers.) In Randy's opinion the rise in dues is worth the benefits covered by the program.

Membership: Joy Gilles reported that dues were due November 1, 2019 and that dues would be considered delinquent as of March 1, 2020.

Wagon Master: Dave Burns provided this report. A September 2020 rally is being planned by Glenn and Sue DeSchryver. At this time a tour of the Tesla plant located in Reno, NV is on the agenda. The membership approved the December 2020 rally be held at the Wine Country RV Resort. Trail Boss and committee are not set at this time.

The Indio Rally was discussed. Members are to meet at the Fairgrounds between 11 a.m. and noon on Sunday. Canopies and tables are needed for the community area. According the new rules, those volunteering to drive the golf carts must view a cart video on FMCA.com. This new ruling was mandated due to insurance concerns.

Old Business: None

New Business: The 2020 Nominating Committee members will be Kerry Ray, Sharon Randell, Ed Frank, and Max Peterson. All nominees were contacted and to the position. It was moved and seconded to accept the Nominating Committee as listed. The motion passed.

Dave Burns and Dale Johnson were appointed to conduct the Chapter's yearly audit.

Denny Wheeler moved to reinstate the "sheriff" at rallies. It was seconded and a discussion followed. A limit of \$1 fines was added to the motion. The fines collected will be donated to Toys for Tots or the Toy Bank at each December rally. It was seconded again, and the motion carried.

Susan Lewis moved to adjourn the meeting at 10:30 a.m. It was seconded, and the motion carried.




