GENERAL PARKING – Use of generator is only permitted from 6 a.m. to 11 p.m.

HANDICAPPED PARKING** – Reserved for those with qualifying medical needs. Limited space. First registered/first served basis. Use of generator is only permitted from 6 a.m. to 11 p.m.

HANDICAPPED W/ELECTRIC** – Reserved for those with qualifying medical needs who must operate equipment relative to treatment of their condition. Limited space. First registered/first served basis. Electric available at 9 a.m. on Wednesday, March 25, 2015, until 9 a.m. on Monday, March 30, 2015. (electric fees apply)

FULL GENERATOR - Generator permitted 24 hours per day.

NO GENERATOR - Space is limited.

FAMILIES WITH CHILDREN - Generator 6 a.m. to 11 p.m. only.

PASSPORT CAR PARKING – Includes entertainment, exhibits and seminars. No overnight parking on event property. Passport coaches cannot be accommodated at the fairgrounds. Passport car parking will be open only until 11 p.m., March 24, 25, 26, 27, 28, 29, 2015. Public parking will be open only during exhibit hours, March 26, 27, 28, 29, 2015.

Parking will be located at Fairplex. Parking will be at the discretion of the parkers.

CARAVANS – Scheduled caravans of 10 coaches or more will be parked on Tuesday and Wednesday, March 24 and 25, 2015. Caravan leaders please call 800-543-3622 to schedule an arrival time.

MAILING AND PARKING PROCEDURES FOR ALL PARKING AREAS

FMCA will begin mailing confirmations as soon as January 26, 2015. Mailed confirmations will contain "date of entry" credentials. Mailed registrations received after March 6, 2015, will be held and processed as gate registrations.

If it is impossible for you to furnish an address for receipt of your confirmation material, they will be held for you at Will Call located at the official Holding Area from 8 a.m. – 5 p.m., Monday, March 23, through Thursday, March 26.

Registered family members will be assigned parking dates of Tuesday, Wednesday and Thursday; March 24, 25, 26, 2015, and families should arrive at the convention on the date stated on their "date of entry" credentials. If you arrive at the convention on a date following your assigned date of entry, you may have to wait in the Holding Area to be parked.

If you have friends or relatives with whom you would like to park, make plans now to register with them. Families who register together and mail their registration forms to FMCA in the same envelope are guaranteed to receive identical "date of entry" credentials. You must arrive together to park together.

Family Reunion parking is considered any lot secured by FMCA. Members of FMCA's parking team will be in the Holding Area from 8 a.m. to 5 p.m. to park coaches. Tram service to all parking areas will be available beginning Wednesday, March 25.

If you are traveling as an individual, a group, or a caravan, confirmation "date of entry" credentials must be displayed on your motorhome to facilitate your entry into the grounds.

All members are asked to display their membership number on their coach or in their windshield.

EARLY ARRIVALS

If you arrive prior to your date of admittance, as identified on your "date of entry" credential, dry camping will be available beginning on Monday, March 23, in the Holding Area.

CA Coasters' Membership Meeting

December 2, 2014

Wine Country Resort, Paso Robles, CA

The meeting was called to order at 1:05 p.m.

In attendance: P. Springer, S. Lewis, P. Meyer, R. Nelson, B. Wyrick, D. Perry, S. Rendall, and D. Wheeler.

A quorum of rigs was present.

D. Wheeler moved to accept the Treasurer's Report as printed in the Coaster Chatter. It was seconded, and the motion carried.

Committee Reports:

Membership: S. Rendall reminded the group that 2015 dues are due December 31; after that date, she will prepare an updated roster.

Photographer: J. Stocksdale announced that Trail Bosses are to find/appoint a person to act as photographer for a rally if he or his assistant, Sharon Rendall, is not in attendance. The pictures can be sent to him via email.

Wagon Master: D. Wheeler reviewed the 2015 rally schedule, asking for Trail Bosses and assistants. Please contact him if anyone can help with a rally. He is busy trying to put the 2016 rally schedule together. He brought up the possibility of doing a longer (in mileage and days) rally in 2016 and perhaps omitting one or two regular rallies.

National Director: D. Gibbs reported that there will be a Pickle Ball area at the Indio Rally; a instructor will be on site. Char Gibbs needs volunteers to help w/ the Ladies' Tea and Fashion Show. The cost has been increased to \$2 because outstanding entertaining has been hired for the event. There has been a change in tram status at the Indio Rally. There will be only two large tractor pulled trams; their route will be restricted to the main driving thoroughfare. Our chapter will be given six more six-seat golf carts; all carts will have assigned routes. The Western Area's new website is up and running (www.wafmca.com). It is easy to navigate and has links to FMCA's and other chapter's websites. The Byways will be uploaded to the website quarterly. The Pomona Rally will need every member to volunteer in some way. If you do not/cannot drive a golf cart, please volunteer in some other way.

New Business

Indio Rally: The deadline for signing up with FMCA is 12/19/14; after that date, the cost will be \$220. The deadline for signing up with the Coaster is 12/15. Please bring pop-ups, tables, and chairs. Ida Jean and Woody Woodruff are in charge of the parade. Dress as a red Martian or an astronaut. Many good accessories and ideas can be found on the internet. Be sure to contact Roger Rendall if you have not signed up to drive a golf cart.

<u>Standing Rules Changes:</u> Two changes to the Standing Rules were approved by the Board and presented to the membership.

- 2. MEMBERSHIP RIGHTS: Chapter members in good standing have the right to:
 - A. Attend any chapter rally and/or meeting, except as noted in Section 8: Rallies, part 1)

8. RALLIES

I. A member must attend a regular rally (excluding Indio or Christmas) within the last twelve (12) months in order to attend the Indio rally as part of the official CA Coasters' contingent or the Christmas Rally.

(These changes remove the requirement for attending any previous rallies during the year before either the Christmas Rally or the Indio Rally)

Discussion ensued. R. Perry moved to amend section I to read: A member must attend at least one regular rally during the year in order to be able to attend the Christmas Rally. If there is space available after the signup deadline, other members may attend. It was seconded, and the motion carried.

(Since Coaster Standing Rules state that Standing Rules can only be changed by a 2/3 majority vote of the Board, this item will have to be tabled until the next Board Meeting.)

- 2. MEMBERSHIP RIGHTS: Chapter members in good standing have the right to:
 - B. Invite guests to attend rallies. (Except Christmas Rally or Indio Rally)

8. RALLIES

J. No guests will be allowed at the Indio RaDennis Zaferislly.

(These changes would allow guests to be invited to the Indio Rally)

Discussion followed. The general impression was that the membership wanted verbage that gave a priority to members over guests when there is a limited number of spaces available for a rally. This was tabled to the next Board Meeting.

Election of New Officers: D. Dixon reviewed the sleight of officers as presented in the November newsletter and asked for nominations from the floor. The final sleight was as follows: President: Susan Lewis and Paul Springer; 1st VP: John Wright; 2nd VP: Leroy Davis; Secretary: Carol Wright; Treasurer: Dale Johnson; Nat'l Dir: Jamie Strachan; Alt. Nat'l Dir: Dennis Zaferis; Chp. Director: Bob Wyrick; Wagon Master: Denny Wheeler; Asst. W. Master: Kerry Ray. K. Dixon moved to accept the sleight as presented, except for the office of President. It was seconded, and the motion passed. A silent ballot was cast for the office of president; Paul Springer was elected. Installation of the new officers will take place at dinner this evening. Dale Johnson, Treasurer, and Dennis Zaferis, Alternate National Director, will have to be installed at a later date.

Birthdays and anniversaries were acknowledged. The Trail Bosses and their assistants were thanked for putting on a fantastic Christmas rally.

G. Partin moved to adjourn. It was seconded, and the motion passed. The meeting ended at 3:25 p.m.
